

**“GRAND TRAVERSE RESORT AND SPA GRAND SLAM GIVEAWAY”
OFFICIAL SWEEPSTAKES RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **PROMOTION DESCRIPTION:** The GRAND TRAVERSE RESORT AND SPA GRAND SLAM GIVEAWAY ("Sweepstakes") begins on March 26, 2026 at 12:00am EST and ends on September 27, 2026 at 11:59pm EST (the "Entry Period"). There is a limit of one (1) entry per person during the promotional period.

The sponsor of this Sweepstakes is Grand Traverse Resort and Spa ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes. Sponsor may be reached by email at marketing@gtresort.com during the Promotion Period.

2. **ELIGIBILITY:** THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF MICHIGAN WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER (“ENTRANT”). ALL OTHERS ARE INELIGIBLE TO ENTER OR WIN AND WILL BE DISQUALIFIED. Employees of Grand Traverse Resort and Spa, and their immediate family and household members, are not eligible to enter. Limit one entry per person. By entering this Sweepstakes, you agree to these Terms & Conditions, and Grand Traverse Resort and Spa’s Terms of Service.

3. **PRIZE:** There will be one (1) winner (“Grand Prize Winner”) for each Game in which at least one Grand Slam Home Run occurs by a Detroit Tigers player during the promotional period. The winner will receive one (1) certificate valid for three (3) consecutive nights of lodging at Grand Traverse Resort and Spa. The certificate provides for lodging only and does not include optional food and beverages, golf, spa, or other expenses. Lodging is based on availability and certain blackout dates may apply subject to the discretion of Sponsor. Lodging may not be separated into individual nights. The Approximate Retail Value (“ARV”) of the Grand Slam Home Run Package is: \$1,200. Only one prize per person and per household will be awarded. All expenses or costs associated with the acceptance or use of the prize are the responsibility of the winner. Prize does not include travel to/from Grand Traverse Resort and Spa. Prizes are awarded “as is” and without any warranty, except as required by law. Gift cards and gift certificates are subject to the terms and conditions of the issuer. Prizes cannot be transferred, redeemed for cash or substituted by winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the stated ARV, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not replace any lost or stolen prize items. Only one prize will be awarded per qualifying Game, regardless of the number of Grand Slam Home Runs hit in that Game. An official “Grand Slam Home Run” is defined in these Official Rules as an official home run as ruled by Major League Baseball while there are base runners on all three (3) bases— resulting in four (4) runs scoring on the play. The Grand Slam Home Run must be officially ruled as a 4-run home run in the box score and official statistics of Major League Baseball. Inside the park

home runs will be eligible to contribute to the winning Grand Slam Home Run provided there are no errors committed on the play, and the hit is officially ruled as a home run.

The lodging certificate expires twelve (12) months after the date of issuance or on December 31, 2027, whichever is earlier. Winner must book and complete the three consecutive nights subject to availability and blackout dates.

RESCHEDULED / CANCELLED/ INCOMPLETE GAMES:

a. If a game is cancelled, without being rescheduled, for any reason prior to becoming an official game, no prize claims will be acknowledged for that game, even if a Grand Slam Home Run is hit by a Detroit Tigers player during the game. A game shall become an "Official Game" once the opposing team has made fifteen (15) outs, and the home team is leading or once the home team has made fifteen (15) outs regardless of score and in each case the statistics are officially recorded by Major League Baseball.

b. If a game is rescheduled to a game date before September 27, 2026, then that game, as rescheduled, shall be eligible to win under the terms of these Official Rules, assuming remaining requirements are met. If a game is rescheduled to a game date after September 27, 2026, then that game shall not be eligible to win under the terms of these Official Rules.

c. Any rain-shortened game, or any game that is less than 9-innings, shall be eligible for the potential prize in these Official Rules as long as the game is considered an Official Game, and the stats of the game are officially recorded by Major League Baseball.

4. HOW TO ENTER: Enter the Sweepstakes during the Promotion Period online by visiting the entry form, which can be found on the following website at: TigersGrandSlam.com. Entrant must submit valid contact information for all fields, including first name, last name, phone number, email address, date of birth, and zip code.

Automated or robotic Entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. Any attempt by Entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, logins or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void Entrant's Entries and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to eligibility verification as set forth below. All Entries must be posted by the end of the Entry Period in order to participate. Sponsor's database clock will be the official timekeeper for this Sweepstakes.

5. WINNER SELECTION: Winners need not be present at any Game to win. The Grand Prize will only be awarded if a Detroit Tigers player hits a Grand Slam Home Run (defined below) during a Game. Before the start of each Game, the Administrator will randomly select one Entrant from eligible Entries. If a Detroit Tigers player hits a Grand Slam Home Run during the Game, the potential winner will notified via email. No winner will be declared if no Grand Slam Home Run is hit by a Detroit Tigers player during the Game. All non-winning Entries roll over for subsequent Games. If no Grand Slam Home Run is hit by a Detroit Tigers player during any game during the entire promotional period, no Grand Prize will be awarded. Once an Entrant wins a prize, their Entry is removed from the pool for all subsequent Games.

ODDS OF WINNING A PRIZE DEPENDS ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED AND THE OCCURRENCE OF CERTAIN RANDOM ACTS. THERE WILL ONLY BE A WINNER OF A PRIZE IF CERTAIN RANDOM EVENTS OCCUR. IT IS POSSIBLE SUCH EVENTS WILL NOT OCCUR AND THAT THERE WILL NOT BE A WINNER OF ANY PRIZE.

Potential Winner must accept a prize by email as directed by Sponsor within two weeks of notification. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive email account(s), technical difficulties associated therewith, or Winner's failure to adequately monitor any email account.

Any winner notification not responded to or returned as undeliverable may result in prize forfeiture. The potential winner will be required to sign and return an Affidavit of Eligibility, Liability Release, Publicity Release, and any tax forms within fourteen (14) days of notification (or such other period specified by Sponsor).
